Garden Cut, Indianapolis, Indiana, is recalling *Garden Cut Foodservice* products containing *all sizes of fresh American slicer cucumbers sold by SunFed brand and packed and shipped by Agrotato, S.A. de C.V.* due to supplier notification of possible *Salmonella* (products are listed below).

Garden Cut has ceased producing and distributing products containing all sizes of fresh American slicer cucumbers sold by SunFed.

Use or consumption of products contaminated with *Salmonella* can cause serious and sometimes fatal infections in young children, frail or elderly people, and others with weakened immune systems. Healthy persons infected with *Salmonella* often experience fever, diarrhea (which may be bloody), nausea, vomiting and abdominal pain. In rare circumstances, infection with *Salmonella* can result in the organism getting into the bloodstream and producing more severe illnesses such as arterial infections (i.e., infected aneurysms), endocarditis and arthritis.

The product was distributed to five states: Indiana, Ohio, Kentucky, Pennsylvania, and Tennessee.
